PRIVACY POLICY ACCORDING TO ART. 13 OF UE REGULATION 2016/679

"Data Controller"

Medeot Mario S.r.l., according to art. 4 of the UE Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as "GDPR") is the Data Controller and according to art. 13 of the GDPR, provides the following information (Information to be provided where personal data are collected from the data subject).

Medeot Mario S.r.l. informs you that the personal data acquired, also with reference to existing legal relationships (e.g. just to give some examples: pre-contractual relationships, contractual relationships, orders, purchases), will be treated according to the GDPR.

The Data Controller, inter alia, provides the following information in relation to the above-mentioned treatments.

"Personal data" (ex art. 4 no. 1 of GDPR) means any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

"Processing" (ex art. 4 no. 2 of GDPR) means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction;

The Processing operations shall be carried out according to fairness, lawfulness and transparency, protecting your privacy and your rights.

Personal Data collected

Personal Data collected regard:

- Identification Data (business name, or name or surname for natural persons, headquarter address, phone, fax, e-mail, tax data, etc.);
- Data related to existing legal relationships, to write up bids and sell products. These data are directly provided by the Data Subject (in its broadest sense).

Processing Purposes

Processing purposes are the following:

- 2. Organizational and administrative management of the contracts or the orders (e.g. executions of operations on the basis of the duties resulting from the contract concluded with the data subject);
- 3. Debt recovery activity for insolvent customers;
- 4. Orders and deliveries management;
- 5. Assert and defend its own rights, also in connection with fraud or debt recovery.

*Categories of recipients

- IT services company;
- Control and supervisory bodies.

Personal data transfer to third country extra-UE

Data subject rights

Data subject can exercise the following rights, in relation to personal data object of the hereby policy, as provided by GDPR:

- Right of access by the data subject [art. 15 of EU Regulation] (possibility to be informed on the treatments carried out on his personal data and, if necessary, receive a copy of them);
- Right to rectification [art. 16 of EU Regulation] (data subject has the right to rectify incorrect data concerning him);
- Right to erasure without unjustified delay ("right to be forgotten") [art. 17 of EU Regulation] (data subject has the right to delete his personal data);
- Right to restriction of processing, as provided by article 18 of EU Regulation, among the other cases, in case of illicit processing or contestation of the accuracy of personal data by the data subject [art. 18 of EU Regulation];
- Right to data portability [art.20 of EU Regulation], (data subject has the right to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided, as provided by the same article);
- Right to object [art. 21 of EU Regulation] (the data subject has the right to object processing of personal data as provided by article 21 of EU Regulation);
- Right to not be subject to automated individual decision-making [art. 22 of EU Regulation] (The data subject shall have the right not to be subject to a decision based solely on automated processing).

Medeot Mario S.r.l., in compliance with the art. 19 of the EU Regulation, proceeds to inform recipients to whom the personal data have been communicated, about any corrections, cancellations or limitations of the treatment requested, where this is possible.

If the purpose of processing pursued by Medeot Mario S.r.l. has as its legal basis the consent, the data subject has the right to proceed, at any time, to the revocation by sending an email to info@medeotsrl.com.

Pursuant to art. 7 of the EU Regulation, the withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

Right to propose a complaint

If the data subject considers that his/her right has been compromised, he/she has the right to lodge a complaint to the supervisory authority (or Data protection Supervisor), according to the methods indicated by the same authority. If you are Italian you can refer to the following link:

Mandatory conferment of personal data

Please note that if the processing purposes have a legal or contractual (or even pre-contractual) obligation as a lawfulness of processing, the data subject must necessarily provide the requested data. Otherwise, it will be impossible for the Data Controller to proceed with the pursuit of specific processing purposes.

Modalities of the processing

Personal data will be processed in paper, digital and telematic form and inserted in the applicable data banks (clients, potential clients, etc.), which can be consulted and processed by the operators and processors designated by the Data Controller who will be able to carry out the consultation, use, handling, comparison and any other appropriate operation, direct or automatic, respecting the legal requirements necessary to guarantee the confidentiality and the security of the data, as well as their accuracy, updating, and their relevancy to the declared aims.
